1. Senior faculty with required qualification has to be appointed as per AICTE Norms. It has been observed that No Principal has been appointed. AICTE Pay scales have not been implemented.

LIBRARY

1. The library is deficient in Books and Journals. More Volumes of books, foreign journals to be added as per AICTE Norms.

LABORATORY AND INFRASTRUCURE

1. Computers are deficient in the Computer Lab. There is no separate lab for Pharmacology. Laboratories and Equipments and other facilities should be provided as per AICTE Norms.
