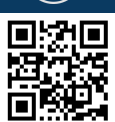

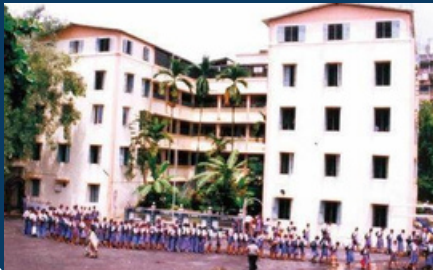

## KNOW NATIONAL EDUCATION SOCIETY - SARASWATHI VIDYA BHAVAN - THE GENESIS AND THE GROWTH

National Education Society (NES) and Saraswathi Vidya Bhavan (SVB) Education Group of 69 Institutions bears eloquent testimony to the power of one visionary. Dr. R. Varadarajan who has been working with single-minded focus and far sight, deserves credit for creating access to quality, value-based education and transforming some of the far-flung suburbs of Mumbai and Thane Districts. The seeds of NES were sown in 1963 with 7 students, enrolling to learn with this visionary, young, and entrepreneurial teacher in his humble 10 by 10 Classroom in Bhandup, then an area known more as a settlement for blue-collar workers. Dr. R. Varadarajan was then a young man in his late teens, he had just come to Mumbai from Thanjavur, Tamil Nadu with only his SSLC qualification, to start his job in a private limited company.



### NES High School & Junior College

This tiny school became the first step to write his trust with education. Initially, there were hurdles in the path but with his steely resolve, keen passion for education, and determination he forged ahead, undaunted, plodding on going door-to-door, collecting funds, and convincing the parents to send their children to school. The benefits of telecommunications and social media did not exist then. He set milestones for himself in institution building so that the God-sent children in the school could have a well laid route for their educational journey.



### NES Ratnam College of Arts, Science & Commerce

Then came the first school building to house the Pre-Primary, Primary and Secondary school, followed by a Junior College. His efforts bore fruit when his school - NES Primary School was first declared as 'A Grade School' by Brihan Mumbai Municipal Corporation (BMC). Accordingly, the required recognition was granted. The school maintained the A Grade status and was subsequently awarded a special incentive grant for Secondary School and Junior College. This provided a great impetus and, as the Institutions grew, so did the achievements - of the school, the students and the Founder. The SSC students raised the bar by achieving 100% passing results. Yet another feather in the cap - Merit Ranks were scored by NES students of High School, Junior College and also his later setup Ratnam Degree College. This set the benchmark for all other institutions established by him one after another till date.



### Oxford High School

He did not rest on his laurels, and, worked even harder for expansion. In the year 1983, a sister trust was formed by him, Saraswathi Vidya Bhavan - to offer professional education and education for the underprivileged. This educational trust was placed under the care of Mrs. Saraswathi Varadarajan.

The Trust established 3 Kindergarten schools followed by Primary and Secondary Schools. Special mention may be made here of SVB's 2 schools - one in the Dharavi slum where the children had no school in the neighborhood, the light of Education had not reached there, and, the second school in a remote suburb, Dombivli, where Saraswathi Vidya Bhavan purchased a sizeable land for educational development in pursuance of its policy of serving the underprivileged first. Dombivli, being in those days, a near jungle and rough terrain, had been excluded from growth due to a lack of educational facilities. However, on the benign command of his beloved Guru, Jagadguru Shankaracharya HH Jayendra Saraswathi Swamiji, Dr. R. Varadarajan began reaching out to the local community and invested in land at Dombivli. Thus, with the inauguration at the hands of His Holiness, the Sankara Vidyalaya was established.

A delegation of foreign visiting education experts offered their support for the Dharavi school in the slum, describing it as a 'wonder school.' The school in rural Dombivli has equally succeeded in awakening amongst the villagers about the value of education.

The Ratnam degree college in Arts, Science, and Commerce under his Education group was also established in 1983. Though it began operations from a makeshift structure, it was soon moved to a concrete college building and offers today, undergraduate and post-graduate Degree Programmes like BMS, B. Com (Banking and Insurance), B.Sc. (I.T.), B. Com (Accounting & Finance), Master Degree Courses in Science & Commerce, MBA Study center under YCMOU and 2 Ph.D programs & also for B.Ed, B.Com & MBA programs. The 2 NES - SVB complexes at Bhandup are now recognized for their Schools, including the secondary school for Hearing Impaired.



**SVB's College of Pharmacy**

In 1993, the SVB Trust established the College of Pharmacy, followed by the College of Education for B.Ed., D.Ed., E.C.C.Ed., a well-equipped I.T. Centre and a Sports School with guidance from Edith Cowen University, Australia, all on its Dombivli land. The Trust has earmarked a sizeable plot of land at Dombivli/Dawadi for a Self-Financing University with world-class courses in degree and post-graduate degrees in all disciplines. The University is taking shape gradually under the stewardship of Dr. R. Varadarajan.

The Founder's emphasis on quality in education led to the National Centre for R&D in Education, Science and Technology – a first of its kind in India's private sector. This R & D Centre established at the behest of HH Jagadguru Sankaracharya of Kanchi, Kamakoti Peetam has been motivating educators to orient themselves towards innovative teaching. Accordingly, His Holiness Jagadguru Sankaracharya National Award for Teachers and National Eminence Awards for eminent personalities of the country in public service were instituted in 2001. These prestigious awards are conferred upon the best teacher of every state and eminent celebrities who walk the extra mile in their profession and careers and make an impact in society. The R&D Centre has brought about a sea-change in the results of all academic institutions, where their findings and recommendations have been implemented.

Not content with achievements so far, the Founder took on special research to study the educational systems prevailing in different countries. He resolved that International Baccalaureate (IB) and Cambridge (CAIE) education were the most promising waves in school education. Thus, the first IB World School was set up in 2004-2005 along with the almost parallel curriculum of Cambridge (CAIE). This school has carved a niche, with the students topping at the country as well as at the world level, besides creating excellent records in sports at NES National Public School.



**SVB's Sankara Vidyalaya**

The Founder-President further scoured the world and brought in several other novel initiatives like Space Science and Pavilions, the NES World Peace Congress, Entrepreneurship, Journalism, Value Education, the annual NES International Science and Technology Festival, and so on. It has further established one more International School with a world Curriculum at Dombivli to provide equal opportunity to all children in the suburbs.

Today, NES-SVB Education Group stands tall, with a strong team of Management and teachers deeply committed to their 69 institutions. In addition to the University, there is on the anvil, a professional institute for Vocational Diploma/Degree College in the Dharavi slum adjacent to the existing school, and also one at Mulund and one at Dombivli to cater to the industrial and technical needs of the community, including a National Centre for Skill Development under the auspices of Nation Skill Development Council, Govt. of India.

NES-SVB Group sets a historic example of how unstinted effort backed by strong values, dedication, and total focus can transform society. Each of the localities housing the 6 complexes, where the educational institutions were established, have metamorphosed into educational hubs, creating access to education and job opportunities, as a stable anchor of hope and aspiration for the youth in particular and the community, in general.

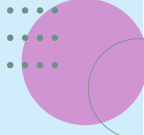

### Library :

### Auditorium:

A spacious, air-conditioned auditorium with 500 seating capacity "S.V.B's, Jagadguru Shankaracharya Shri Jayendra Saraswathi Auditorium" is available in the campus for conducting various events. It is equipped with the provision of sound system, projector, LED screen and backstage.

The institute has an air conditioned, well- furnished and suitably equipped seminar hall with audio visual system and seating capacity of 150.

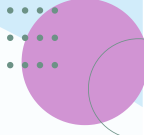


### Museum:

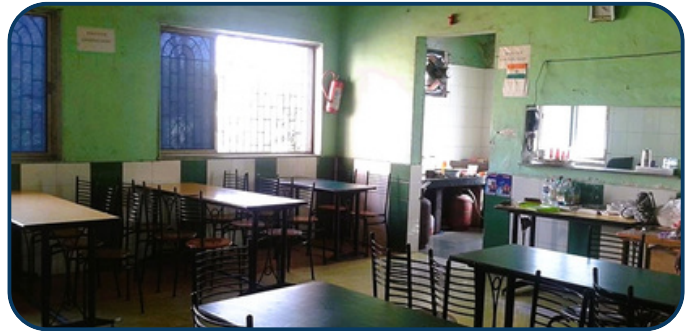


**Medicinal garden:**

A well-stocked hygienic canteen for students and staff members is available in the campus.



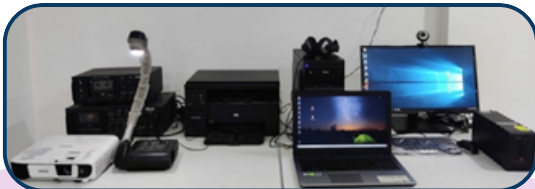
**Common Rooms:**

Separate common rooms for boys and girls with sufficient space for games, indoor sports, and other activities.



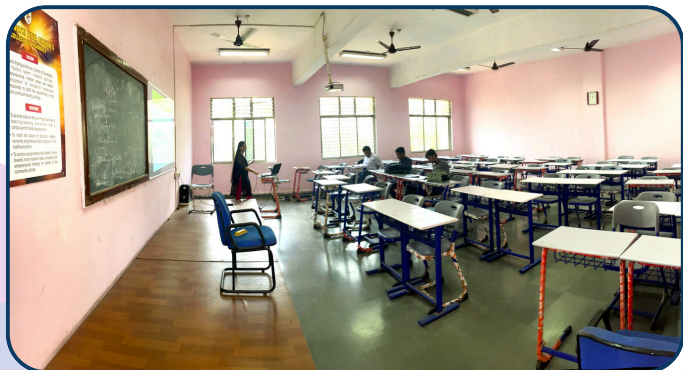
**Technology Room:**

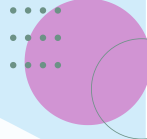

## OTHER FEATURES

### **Railway Concessions:**

Students aged below 25 years can avail this concession. The railway concession is issued for local travel i.e. from station closest to the residence to Dombivli on monthly or quarterly basis. Registration for the railway concession has to be made in the prescribed format available in the college office.

### **Commuting Option:**

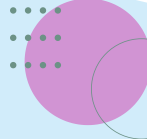

**Ph.D. (Tech) in Pharmacognosy & Phytochemistry**

The institute is an approved Research Centre of the University of Mumbai with an intake capacity of five. The institute has two approved guides. The eligibility to enroll to the programme is as per the Ordinances 0.5473, 05474, and 0.5476 of the University of Mumbai as mentioned in VCD no. Exam/Thesis/ Univ/VCD/947 of 2018

**Eligibility Criteria for admission to Ph.D. as per University of Mumbai:**

- Candidate should hold a Master's degree in Pharmacy with at least 55% (50% in case of reserved category) or equivalent grade from a recognized University.
- Candidate should be GPAT qualified or PET qualified with a minimum of 50% (45% in case of reserved category)
- The candidates fulfilling the above criteria are interviewed by a selection committee constituted as per the guidelines.

**Duration of course:**

- Minimum three years & maximum six years including the course work, from the date of admission. After successful completion of the course, the student has to submit the synopsis of the project proposal for the approval by Research Recognition Committee of the University of Mumbai. Once the approval of the project proposal is received the procedure of registration of the student at the University of Mumbai through the institute takes place.
- The student has to carry out the project work under the research guide assigned followed by submission of the synopsis of the research work carried out in not less than 24 months upon registration. Once the synopsis is submitted the students get 6 months from the date of submission of the synopsis to submit the thesis.
- The Ph.D. degree is awarded upon successful defense in viva voce examination.

- Candidate shall apply online for cancellation and submit a duly signed copy of the system-generated application for cancellation of admission to the Institute. Upon such cancellation, the candidate shall lose the claim for the seat. The institute shall refund the entire fee to the candidate after a deduction of Rs. 1000/- towards processing charges and return all his/her original documents submitted to the Institute.
- Candidate shall not be entitled to any refund of his/her except the security deposit & caution money deposit if the online cancellation is effected by the competent authority of the cut-off date prescribed by competent authority.

### Other Fees :

Over and above the tuition fee and development fee; students will be charged caution money, university dues like enrollment, eligibility, PG registration fee, examination fee, gymkhana fee, library fee, internet & email charges, group insurance premium, journal charges etc. separately as applicable. This will be notified as per the norms of University of Mumbai.

### Scholarship Scheme & Concession in Fees :

Eligible students can avail the benefit of the scholarship schemes introduced by Government of Maharashtra/Government of India (only one scholarship/free ship at a time) (Ref: DTE circular dated 31/03/16) for getting concession in fees/ refund of fees by applying within date, complying with all eligibility conditions and required documents specified by the respective scholarship authorities from time to time. ## WORKING SCHEDULE & CODE OF CONDUCT

### **Working Schedule of the college:**

Monday to Friday - 9.30 am to 5.30 pm

Saturday - 9.30 am to 2 pm

The timetable for the respective class is displayed on the noticeboard

### **Attendance Compliance:**

- Attendance in all lectures, Practicals, tutorials, and examinations is compulsory for all students. Bunking of lectures/ Practicals is strictly prohibited and 100% attendance is expected from the students. A maximum of 25% default in attendance covering the student's sickness and other genuine causes supported by suitable explanation in writing can be considered. If attendance is not found to be 75% of actual instructional days and if absence of 25% is not supported with valid reasons, the term will not be granted and the student will not be allowed to appear for the Examinations conducted on behalf of the University (University of Mumbai ordinance No. 119).
- A leave note duly signed by the parent should be produced on the next day for one day of absence. Absence on medical grounds for 3 days or more should be supported by medical certificate from the doctor. To monitor the attendance, the percentage of attendance is assessed for each student at the end of each month. Parents of the students, having poor attendance are called to meet the college authorities.
- Attendance of the students along with the covered syllabus is communicated to students through a mobile application 'The TeachUs app'.

### **Prohibition of Ragging:**

- The college has an active Anti-Ragging squad to ensure a 'ragging-free' environment. It strictly follows the Maharashtra Prohibition of Ragging Act, 1999, and its amendments and recent guidelines of AICTE in order to prevent ragging.

### **Use of Mobile Phone:**

- Use of mobile phones or any other electronic gadget inside the college campus (except the canteen, washrooms, and common rooms) is strictly prohibited. It has to be switched off or kept on silent mode before entering the college campus. If a student is caught using a mobile in restricted areas, it is confiscated for 24 hours and is released against a fine of Rs. 100/- by cheque.

### **Dress Code:**

- Students are required to be in decent attire and footwear.
- Boys: Any full trousers/jeans with half or full-sleeved shirts. T-shirts are not allowed.
- Girls: Any traditional Indian dress or full trousers/jeans, half or full-sleeved shirts. Half or 3/4th pants, cargo pants, T-shirts, and sleeveless dresses/tops are not allowed.

### **Identity Card (I-Card):**

- Every newly admitted student, whose admission is confirmed, must get the I-card from the library. He/ She should wear this I-card at all times. No entry from the main gate is allowed without an I-card.
- Issue of Duplicate I-card: In case of loss of the original I-card, students can obtain special permission for 03 days from the principal to enter college premises. The student whose I-card is lost must take a duplicate I-card by paying Rs.100/-.

- Every student is responsible to the college and should take utmost care of the college premises and property. Any damage done to the college's property is to be compensated individually or collectively in the form of fine. Scribbling on the walls and desks is strictly prohibited. Severe punishment (including a fine) shall be imposed if any student is found scribbling on the walls /desks.
- Students should observe strict punctuality. If a student is late, more than 3 times a month, he/she is marked absent for one day, and appropriate action is taken.
- Students should be particular about the cleanliness of the college premises. They should use the bins specially provided for litter. Students should switch off the lights, fans, etc. when not required, and also while leaving the classroom, laboratory, and library.
- No student or staff member shall collect any money without the written permission of the Principal.
- Active participation, discipline, and good behavior are expected from the students at all social gatherings and celebrations of the college.
- No notice shall be put on the notice board, including blackboards without the written permission of the faculty members authorized in the matter concerned.
- All programs, meetings, gatherings, picnics, hiking, etc. will be conducted only with prior written approval of the Principal.
- Students are not allowed to go out of the college premises during the schedule. In case of any emergency or genuine reason, the student can collect a gate pass from the office with permission of the class in charge and the Principal.
- Any student who is persistently insubordinate or is guilty of malpractices in connection with examinations or has committed an act of serious indiscipline or who in the opinion of the head of the institution has an unwholesome influence on his fellow students may be expelled or suspended from the college for a specified period. Insubordination and indecent language or conduct are sufficient reasons for the dismissal of a student.
- Students who are found adopting unfair means at the examination will be dealt with as per the University Rules MU Act 1994 and Provisions of Act No.XXX1/1982 as the case may be.
- Students found indulging in unfair means, submission of false documents, or in any activity contrary to the rules of discipline and provisions of acts and laws enforced by the Government, will be liable to be expelled from the college without any notice by the Principal and Management.
- Students should make themselves familiar with the rules and regulations of the college from time to time. Students are expected to accept and observe all the rules and regulations of the institution to the satisfaction of the college authorities.

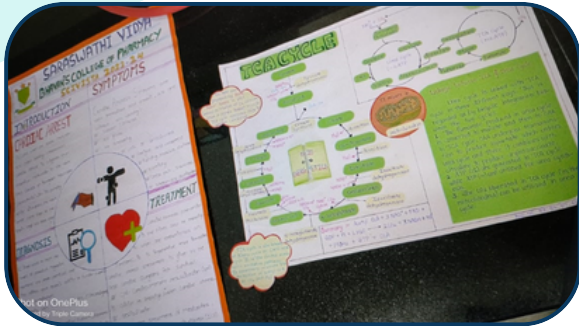
## CO-CURRICULAR & EXTRA-CURRICULAR ACTIVITIES

### STATE LEVEL PHARMA QUIZ & YOUNG SCIENTIST INNOVATIVE PROJECT AWARD:

SVB's College of Pharmacy is one of the foremost institutes, that firmly believes that study and competition amongst learners in their formative years shape up their conceptual knowledge. To encourage students to look beyond their textual knowledge, SVBCP envisaged the commencement of the "State Level Pharma Quiz" in the year 1999. Synergistic with this, the institute started another colossal event the "YPIPA or Young Pharmacist Innovative Project Award". SVBCP has endeavored to recognize and promote quality research among budding pharmacists. The institute provides a stage for nascent scientists to bring out their original pioneering ideas and skills at this level. The pharmaceutical sector is undergoing a paradigm shift, which has placed greater demands on researchers of the academic sector and pharmaceutical companies to find innovative solutions to increase the output of new drugs.

The YPIPA event offers a platform for undergraduate students to showcase their novel research ideas in the form of models/ posters. Students from all over Maharashtra participated in this event. 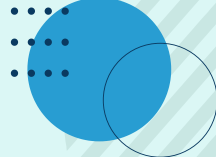

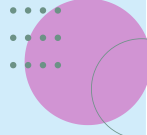
IPA organizes Rx event every year for Pharmacy Students, which include cultural, sports and other competitions. More than 20 Students participated and stood second runner up in sports.

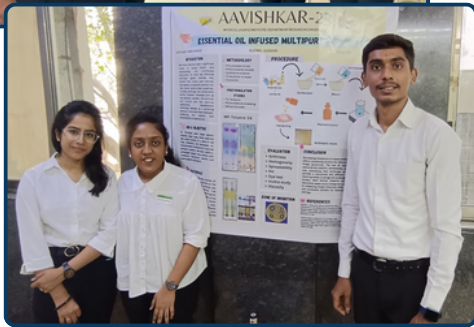




## INTERCOLLEGIATE / INSTITUTE / DEPARTMENTAL RESEARCH CONVENTION

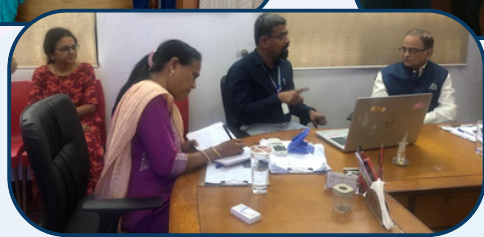
